They are allowed to join between 03.07.2026 and 10.07.2026 on any working day at the University Campus, failing which they will forfeit their claim to join. No TA/DA is admissible for joining.

Candidates are required to submit, at the time of appointment, two sets of self-attested copies of certificates, two passport-size photographs, and the joining report. 
